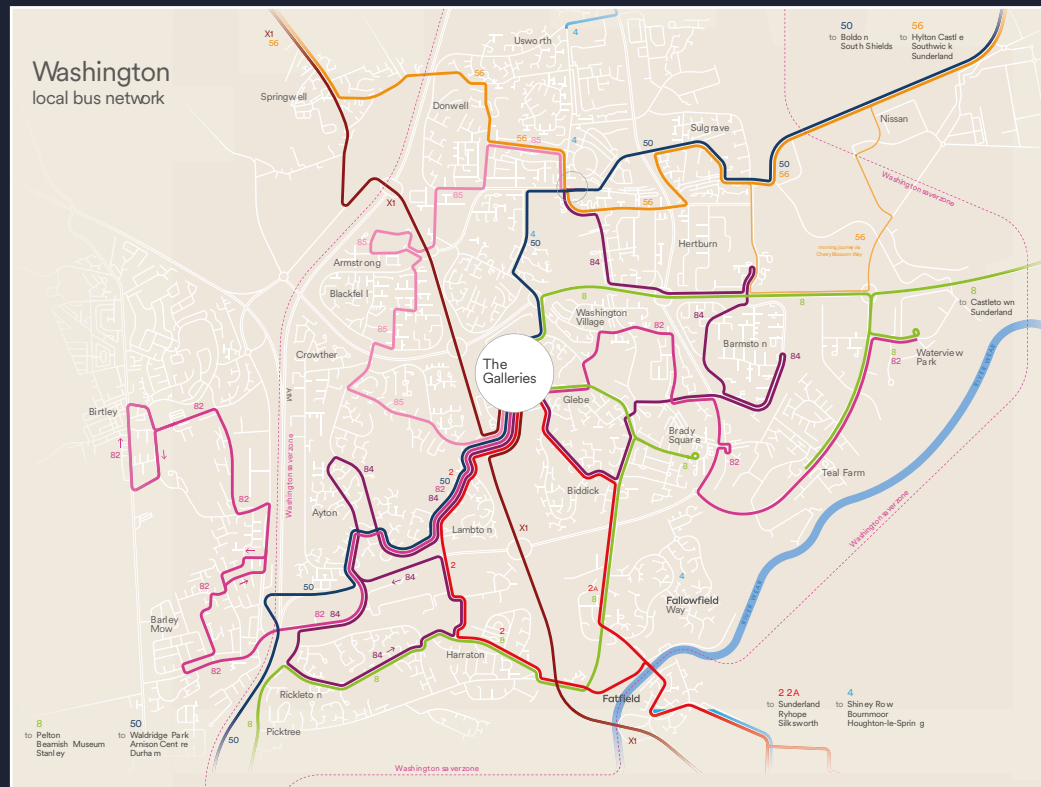

Washington sits between Durham, Newcastle and Sunderland. The Galleries is the town centre providing a focal point for the local population.

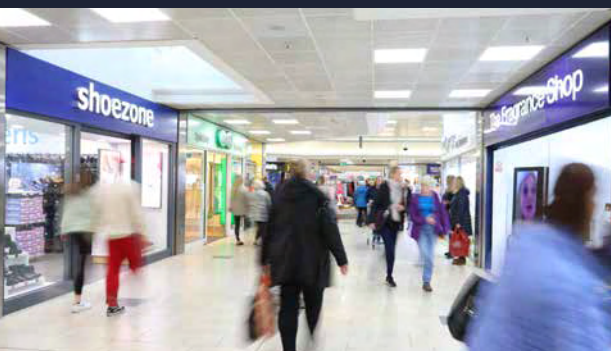
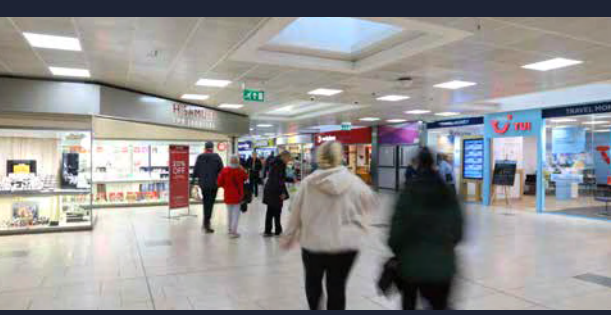

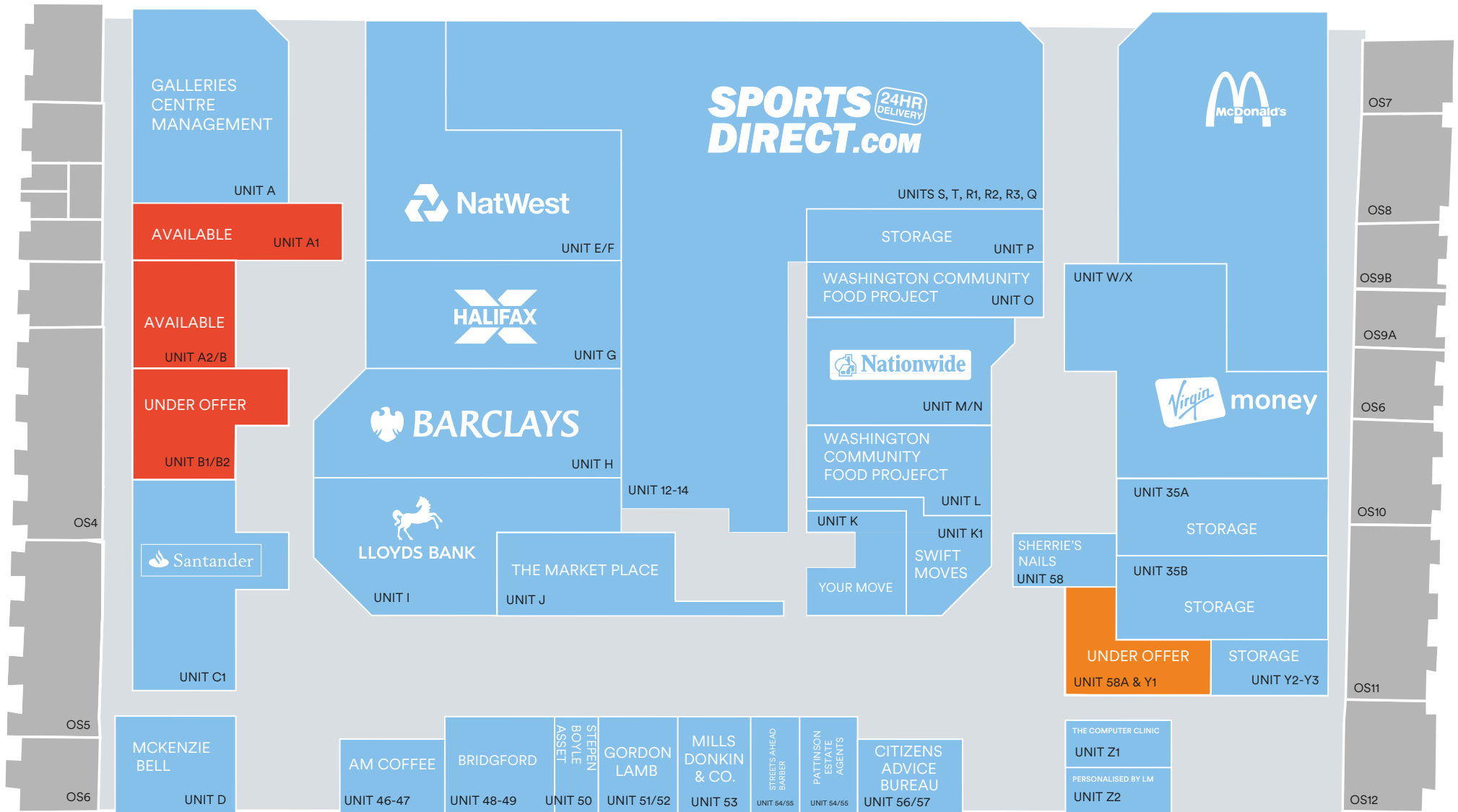

# FIRST FLOOR

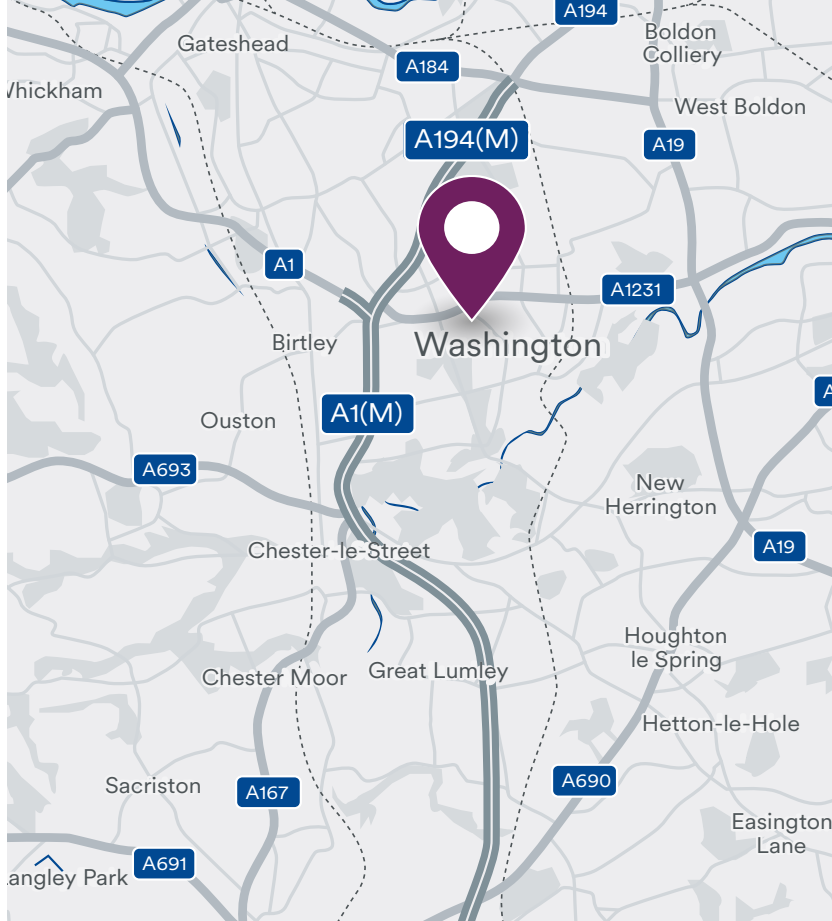
